Dear Minister:

I am writing to you today on behalf of the National Union of Public and General Employees (NUPGE) and its more than 390,000 members across Canada. I was deeply concerned to hear the news today of the military seizing power in Myanmar.

NUPGE, with the leadership of the Advisory Committee on Women's Issues (ACWI), has been actively monitoring and speaking out about the genocide against the Rohingya. I have previously written Prime Minister Trudeau, urging your government to take stronger measures to protect the Rohingya from further prosecution and violence.

NUPGE welcomed the move by Canada and the Netherlands to intervene in the Rohingya genocide case before the International Court of Justice. We all have a responsibility to speak out and to take action to stop the Rohingya genocide.

Canada has previously recognized the role of Aung San Suu Kyi in the Rohingya genocide. Also, Myanmar's military has played a major role in the systematic violence, murder, and displacement of the Rohingya. And so, the potential impacts on the Rohingya of today's military takeover, and the unrest that may follow, are of serious concern to us, and should be a priority of the Canadian government in its response.

I implore the Canadian government to continue monitoring the situation in Myanmar, specifically as it affects the Rohingya. I also reiterate NUPGE's previous calls on the Canadian government to support the Rohingya's ongoing needs and movements on the ground, and to support Rohingya-led grassroots struggles for peace.
