But yet I know in my heart that someone has to pay a sacrifice to make things better for our people. The Secrifice I have made, when I really sit down to thick about it, is nothing compared to What our people of 100 years ago, or 50 years ago or 25 years ago made. Some gave their lives. Some had to stand there and Watch their children die in their arms. So the sacrifice I have made is nothing compared to those. I have gone too far now to start backing down. I don't give up, not until my people are free will I give up. If I have to sacrifice some more then I sacrifice some more.


HE IS STILL NOT FREE. Leonard Peltier is still locked behind bars in an American prison—still condemned to serve out a double life sentence for the 1975 shooting deaths of two FBI agents.

### This is wrong.

**It is wrong** because there is no solid evidence even to accuse Leonard Peltier of the deaths let alone convict him. It is true that Leonard was a leader of the American Indian Movement. It is true that he was on the Pine Ridge Reserve in South Dakota when the agents were killed. It is true he fled home to Canada after the killings on that June 26th morning in 1975. But that is all that has ever been proved to be true about Leonard Peltier's connection to the deaths.

**It is wrong** because the process used to return Peltier from Canada to the USA to stand trial was a crime in itself. The truth is: key evidence to incriminate Peltier was fabricated; and the chief FBI witness was a victim of FBI manipulation and coercion.

**It is wrong** because once back in the USA Leonard Peltier was tried and convicted on false evidence. The FBI now admits it. They also admit they cannot now—and never could—link Leonard Peltier to the crime scene. **It is wrong** because if Leonard Peltier did anything wrong June 26th, 1975 on the Pine Ridge Reserve, whatever it might be has never been presented or proven at any time, to any court of law, anywhere on earth.
